Organist William Douglas will present a concert on the four manual Reuter organ at First Baptist Church in Florence on Saturday, August 4 at 6:00 p.m. The church is located at 300 S. Irby Street.

William Douglas started playing the piano at age five under the instruction of Barbara S. Lawrimore, and began organ studies three years ago under the tutelage of Dr. Keith F. Taylor, Director of Music at Trinity United Methodist Church in Darlington. Currently serving as Music Ministry Intern at St. John's Episcopal Church, William plays for Sunday morning services and works with adult, children, and handbell choirs.

The program will include Karg-Elert's "Praise the Lord with Drums and Cymbals," movements from Handel's "Royal Fireworks Suite," works by Bach, and more. William has billed this as a "farewell" concert as he will be leaving Florence in August to pursue a degree in Organ Performance at the University of South Carolina.

Prior to his appointment at St. John's, William served as organist at Mizpah Baptist Church and pianist at Oakdale Baptist Church. William graduated in June from Wilson High School, where he served as ROTC Commander as well as accompanist for a variety of music events.

On Sunday, August 12, 2012 at 5:00 p.m., Trinity United Methodist Church, 128 Pearl St, Darlington, SC will present William Douglas in recital on the church's Canadian Casavant Pipe Organ.

The inspiration for this service was the composer's "deep concern that nothing had been written since the Elizabethans which can properly be called a Folk Mass" and that church music is utterly foreign to the majority of people. The theory behind this setting is that the music used at the Holy Eucharist in apostolic days was the normal music of the day and only became "church music" when it arrived with definite church associations in Western Europe where it

developed itself into the plainsong we know. In the title, the word "Folk" is used literally to mean the normal every day popular type of music.

# AGO NATIONAL COUNCIL ADOPTS NEW MISSION STATEMENT

NEW YORK CITY—The AMERICAN GUILD OF ORGANISTS (AGO) announces a newly adopted mission statement, which was approved by the AGO National Council at its July 2012 meeting in Nashville. The new mission statement begins with a succinct, memorable statement that focuses on how the AGO makes a difference in the world. It is followed by a list of goals that help define how the mission will be accomplished.

The mission of the American Guild of Organists is to enrich lives through organ and choral music.

### To achieve this, we:

- Encourage excellence in the performance of organ and choral music;
- Inspire, educate, and offer certification for organists and choral conductors;
- Provide networking, fellowship, and mutual support;
- Nurture future generations of organists;
- Promote the organ in its historic and evolving roles; and
- Engage wider audiences with organ and choral music.

"The new mission focuses on more than just serving the needs of dues-paying members," declared AGO Executive Director James Thomashower. "This is a mission that gives the work of the Guild meaning in the context of our society."

The Guild's prior mission statement was developed early in 1998. Over the last three years, the AGO National Council and various task forces have reviewed AGO members' responses to a long-range planning questionnaire to determine what is most important to members and consider afresh what the Guild should plan to achieve organizationally.

In 2011, a task force was formed to develop a new mission statement. Members of the task force were AGO Councillor for Region IX Leslie Wolf Robb, Director; AGO Treasurer Calvert Johnson; AGO Councillor for Region VI Jan Kraybill; and AGO President Eileen Guenther (ex officio). The task force drafted three mission statement options and asked AGO members to complete an online survey in April 2012. Based upon the responses of Guild members, the AGO National Council endorsed the new mission statement to challenge, energize, and equip AGO members to continue and expand the work of the Guild both now and in the years to come.

"The Strategic Planning Workbook for Nonprofit Organizations defines a mission statement as 'What you intend to accomplish, your organization's overall goal, the reason you exist'," stated AGO President Eileen Guenther. "Other books on leadership define it as what an organization can do uniquely—better than any other organization. Not-for-profit organizations must revisit their mission statements periodically to be sure they reflect current environmental realities as well as the organization's current needs and objectives."

The AGO President's Award was presented to Martha Rivers Ingram of Nashville. The prestigious award, created in 1988, is presented biennially to recognize outstanding contributions to the art of the organ in the United States. The 2012 President's Award recognized Ms. Ingram "in gratitude for her generous patronage of the King of Instruments, vision for the Nashville Symphony and the Schermerhorn Symphony Center, and commitment to expanding the musical horizons of the Nashville community."

Created by the AGO National Council in 1999 to honor the memory of the Guild's distinguished past president, Edward A. Hansen, AAGO, the prestigious award is presented biennially to recognize individuals who have demonstrated outstanding leadership in the AGO. The 2012 Edward A. Hansen Leadership Award was given to the Fyfes "in recognition of their commitment to excellence in music; unparalleled knowledge of sacred music; their roles as teachers and mentors; and their leadership, devoted service, and extraordinary generosity to the AGO."

Competition prizewinners were recognized on Wednesday, July 4, 2012, at the AGO Annual Meeting, held in conjunction with the 51st biennial AGO National Convention in Nashville, Tenn. # NATIONAL YOUNG ARTISTS COMPETITION IN ORGAN PERFORMANCE

The National Young Artists Competition in Organ Performance promotes the highest level of organ performance. The competition serves as a springboard for emerging young organists, allowing them to continue to develop their performance ability by participating in the various demanding stages of this competition. Established in 1950 and held biennially, the competition is open to organists between the ages of 22 and 32.

The 2011–2012 NYACOP was conducted in four rounds. Twenty applicants were accepted as official competitors based upon their submitted recordings and applications outlining their recital experience and demonstrating their readiness for the rigorous performing demands of the first-prize winner. In the anonymous, recorded elimination round that followed, seven NYACOP competitors were selected to advance to the semifinal round, which was hosted by the Cleveland (Ohio) Chapter at the Cleveland Museum of Art on May 25. Three finalists were chosen to participate in the final round, held in conjunction with the AGO National Convention, on July 1, at Christ Church Cathedral in Nashville.

Judges for the final round were Wilma Jensen, Sandra Soderlund, and John Chappell Stowe, AAGO, CHM. Major support for the 2011–2012 NYACOP was provided by Karen McFarlane Artists, John-Paul Buzard Pipe Organ Builders, Kegg Pipe Organ Builders, the Martin Ott Pipe Organ Company, the Cleveland (Ohio) AGO Chapter, and the Nita Akin Competition Fund.

# NATIONAL COMPETITION IN ORGAN IMPROVISATION

The National Competition in Organ Improvisation advances the art of improvisation by recognizing and rewarding superior performers in the field. Improvisation is the pinnacle of achievement for a musician who can combine the elements of performance and composition simultaneously in the creation of a new work of art. Since 1990, the AGO NCOI has motivated and inspired hundreds of the most talented organists in America. Today, it is the preeminent competition in North America dedicated to preserving and advancing improvisation at the organ, and is open to all regardless of age or country of citizenship.

The 2011–2012 NCOI began with a preliminary recorded round in the fall of 2011. Five semifinalists were selected as official competitors in January 2012. Semifinal and final rounds, held in conjunction with the AGO National Convention, were held at Belmont United Methodist Church in Nashville.

Judges for the semifinal and final rounds were Matthew Dirst, Pamela Ruitter-Feenstra, and Todd Wilson. Major support for the 2011–2012 NCOI was provided by McNeil Robinson, Dobson Pipe Organ Builders Ltd., Pamela and Steven Ruiter-Feenstra, and David and Robin Arcus.

A flourishing tradition of improvisation has always been fundamental to a truly vital musical culture. Although musical extemporization has enjoyed a rich heritage in Europe for many centuries, the art form is in perilous risk of extinction in America except among a few organists and jazz musicians. As the premier competition for organ improvisation in America, the NCOI continues to set the standard for organists seeking to demonstrate their skill in extemporaneous performance, the highest and most challenging musical art form.  $\blacksquare$

## AGO/Marilyn Mason Award in Organ Composition Presented to Nicholas O'Neill

NEW YORK CITY — The American Guild of Organists (AGO) honored three award winning composers at its Annual Meeting on Wednesday, July 4, during the AGO National Convention in Nashville, Tenn. AGO President Eileen Guenther presided over the award presentations to Craig Phillips of West Hollywood, Calif.; and to Nicholas O'Neill and Alan Smith, both of Great Britain.

The 2012 Distinguished Composer Award was presented to Craig Phillips. The prestigious award, created in 1986, is presented biennially to recognize outstanding composers of organ and choral music in the United States. Previous award recipients include: Virgil Thomson, Ned Rorem, Daniel Pinkham, Samuel Adler, Dominick Argento, William Albright, Conrad Susa, Emma Lou Diemer, Dan Locklair, William Bolcom, Alice Parker, Carl Schalk, Margaret Sandresky, Richard Proulx, and Stephen Paulus.

The 2012 AGO/ECS Publishing Award in Choral Composition was presented to Alan Smith for his anthem, There Is a Flow'r, based upon a 15th-century text by John Audelay. The award included a cash prize of \$2,000 and publication, both provided by the ECS Publishing Co., and a performance at the 2012 AGO National Convention in Nashville. Mr. Smith is the first British citizen ever to receive the award.

The 2012 AGO/Marilyn Mason Award in Organ Composition was presented to Nicholas O'Neill for his Festive Voluntary. The award included a cash prize of \$2,000 provided by Marilyn Mason, publication by Hinshaw Music Inc., and a performance at the 2012 AGO National Convention. Mr. O'Neill is the first British citizen ever to receive the award.
